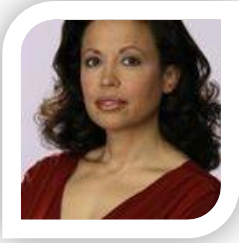

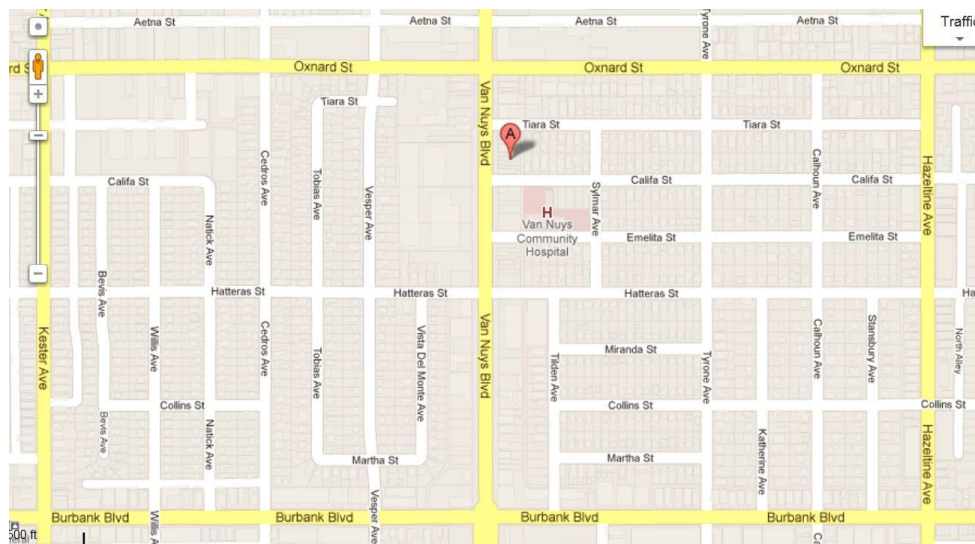
This educational seminar is designed to explain and demystify the process.
